The past four fiscal years (ending June 2024) brought a lot of changes to the Unity Medical Center Foundation, especially post-COVID. As a public 501(c)3, we want to share these changes, as well as our regular fundraising activities, with our donors.

For example, fiscal year 2022 ended with the official closing of the Capital Campaign, which reached just over \$1 million in six years.

Also in FY22, our new patient, provider/staff and programs endowments started paying out 4 percent of its total invested after one full calendar year.


Our special events continue to raise funds for more specific needs at UMC. In FY21, we shifted the focus of the annual Friends of the Foundation Luncheon from a fundraiser to a donor appreciation event. 


#### FISCAL YEAR 2023-2024

# DONOR DEMOGRAPHICS




### TOTAL DONORS: 769

### GIFTS RECEIVED FROM 26 U.S. STATES


It's no surprise that most

### GOLF TOURNAMENT



#### **NET RAISED FOR UMC: \$22,000**

Annual golf tournament revenue is reported on a calendar-year instead of fiscal-year basis since each tournament overlaps fiscal years.

The FY24 Golf Tournament, held July 2023, included 18 teams (85 golfers) and 50 sponsors.

Funds raised went toward the Spyder2 limb positioner for Dr. Darin Leetun to use during shoulder joint replacements. As of April 2024, Dr. Leetun had completed over 300 procedures.


The tournament was canceled in 2020 because of COVID. Otherwise, it has been held for the past 33 years at Fair Oaks Golf Course in Grafton.

### HARVEST AUCTION



#### **NET RAISED FOR UMC: \$120,000**

The 2023 Harvest Auction held in FY24 was the second hybrid in-person and online event ever held by the Foundation, following two years of online-only auctions during the COVID pandemic.

Over 200 people attended the FY24 event, which included an online silent auction, reverse auction, Lucky Charm and raffle drawings, as well as the Last One Standing paddle game.


Funds raised went toward a new medication mixing room at Unity Medical Center, as well as 50 new IV pumps..

### **NET RAISED FOR UMC: \$32,000**

Giving Hearts Day is an annual one-day online fundraiser hosted by Dakota Medical Foundation in Fargo, N.D. Unity Medical Center Foundation has participated for the past eight years.

Funds raised went toward a surgical table that pairs with UMC's new daVinci surgical robot controlled by General Surgeon Dr. Mike Bittles.


Giving Hearts Day was most successful in FY22, thanks to one one \$30,000 donor.

### PATIENT Endowment



#### **BALANCE (FY24 END): \$315,700**

As mentioned on Page 3, the Foundation Board approved the creation of the Patient Endowment at the end of CY20. A 4% interest payout became available in FY22.

With those available funds, the UMCF purchased a fetal heart monitor for the Grafton Family Clinic. Then the stock market dropped, pausing spending from this fund until it rebounded above \$300,000 in FY24. New funds for an ultrasound table will be spent in FY25.


Donations that specify "Medical Equipment" or "Patient Care or Equipment" on gift envelopes are invested in this endowment.

## PROVIDER/STAFF ENDOWMENT



#### **BALANCE (FY24 END): \$82,338**

As mentioned on Page 3, the Foundation Board approved the creation of the Provider/Staff Endowment at the end of CY20. A 4% interest payout became available in FY22.

With these funds, the UMCF primarily provides scholarships to Unity staff. However, with no qualifying applicant in FY24, the UMCF moved to its second priority (continuing education) by paying for two Radiology Department staff to attend a mammography conference, as well as for UMC staff members to complete interpreter training.



### PROGRAMS ENDOWMENT




#### **BALANCE (FY24 END): \$42,234**

As mentioned on Page 3, the Foundation Board approved the creation of the Programs Endowment at the end of CY20. A 4% interest payout became available in FY22.

Funds from this endowment in FY23 supported UMC's Tree of Lights Community Remembrance Ceremony (pictured) and community weight loss programs. Additional funds will be spent in FY25.

Donations that specify "Health Programs" on gift envelopes will be invested in this endowment.

### FOUNDATION GOALS



- Grow all endowments, especially Programs
   Endowment (currently the smallest of the three).
- Increase major gift pledges (\$10,000+ over five years). Ideally, UMCF would receive the equivalent of 18 \$10,000 pledges annually.
- Develop strategic plan in conjunction with Unity Medical Center.
